1. In order to seek re-accreditation with EMDR UK, applicants must be paid up members of the Association.
2. Accredited EMDR practitioners and consultants are responsible for ensuring they engage in ongoing supervision with an accredited consultant
3. Applicants must apply in writing, indicating whether they are applying for Practitioner or Consultant re accreditation. C&A re-accreditation (practitioner or consultant) should be applied for at the same time the Generic Re Accreditation falls due.
4. Applicants are asked to provide a checklist, in their letter of application, of the documentation they are providing as evidence in support of their application.

5. Continuing Professional Development

Individual practitioners are responsible for their own continuing professional development (CPD) throughout the entire five-year registration period and are asked to list their CPD credits in their application. Applicants are not required to provide copies of their CPD certificates but the consultant supporting their application for re accreditation should provide written confirmation that he/she has seen the necessary certificates. The accreditation committee will carry out occasional spot checks.

EMDR CPD credits are awarded by the UK Association and by EMDR Europe for EMDR specific continuing education and development.

CPD credits are not awarded for training.

EMDR UK does not award CPD credits to online courses but is awarding CPD credits to events which meet the Association criteria, and which are currently being delivered on on-line platforms.

The credits submitted must include participation in EMDR UK or EMDR Europe accredited workshops and in the 5-year re accreditation period, **include attendance for a minimum of two days at a UK or Europe conference** (the two days can be attended separately in two different conferences). For those seeking re accreditation as consultants, attendance at a minimum of **1 EMDR UK or Europe consultant day** during the 5-year period is also required.

From January 2020 the credits required for reaccreditation with EMDR UK as practitioners and consultants increased. The increase is being phased over a 5-year period rising to a minimum of 75 CPD credits, (50 of which must be EMDR specific CPD credits) in 2024. Applicants seeking re accreditation as Child and Adolescent Practitioners and Consultants, after January 2020, will be required to provide evidence that a third of the minimum credits required are from events specifically for those working with children and adolescents.

- **2021 - 35 EMDR specific CPD points plus 25 related credits (C&A specific EMDR CPD points 11.5 of the 35)**
- **2022 - 40 EMDR specific CPD points plus 25 related credits (C&A specific EMDR CPD points 13 of the 40)**
- **2023 - 45 EMDR specific CPD points plus 25 related credits (C&A specific EMDR CPD points 15 of the 45)**
- **2024 - 50 EMDR specific CPD points plus 25 related credits (C&A specific EMDR CPD points 16.5 of the 50)**

6. References

Applicants for re-accreditation as Practitioners must provide two letters of recommendation, one from an EMDR Europe Consultant regarding their clinical work and a second professional reference from a clinical supervisor/manager.

For those seeking re accreditation as Consultants two letters of recommendation from EMDR Europe Consultants are required; one regarding their clinical work and role as a Consultant in offering Clinical Supervision to other EMDR practitioners, and the second surrounding the applicant's standing and contribution within the field of EMDR. Please Note References for applicants seeking re accreditation as Child and Adolescent Consultants should be from a Consultant supervisor who is experienced in working with children and adolescents.

Consultants providing references are asked to include in their letters of support the following text; signed and dated.

I attest that this is an honest and valid evaluation of the supervisee

I understand that if for any reason information is forthcoming to suggest that this is not the case the consultant and/or supervisee may forfeit their accreditation and possibly Association membership.

7. Confirmation of **at least three** of the following activities to cover the previous five year registration period

Attendance and/or participation in EMDR trainings

Attendance and/or participation in area related trainings

Attendance and/or participation in conferences

Attendance and/or participation in EMDR focused workshops

Attendance and/or participation in area related workshops

Involvement in both the provision and receipt of EMDR Clinical Supervision

EMDR Case Consultation

Relevant publications relating to EMDR

EMDR research focused activity

Contribution to raising the profile of EMDR

All applications will then be considered through the EMDR UK Accreditation Committee. If successful, the period of renewal will be for a further five-year period.

PRACTITIONER RE ACCREDITATION

2 references are required. The first should be from your Consultant Supervisor which should include some information on your development as an EMDR practitioner and confirmation they have seen the certificates in respect of the above CPD activity. The second should be a professional reference from a clinical supervisor or manager who can comment on your clinical work and professional standing.

CONSULTANT RE ACCREDITATION

2 references are required, both from EMDR Consultants. The first should be from your EMDR Consultant Supervisor regarding your clinical work and role as a consultant offering supervision to other EMDR clinicians and confirmation they have seen certificates in respect of the above CPD activity. Consultant references should include some information regarding your activities as listed in point 7 (page 3).
